Why does Aston Reid Lawyers collect personal and sensitive information?

Aston Reid Lawyers is a supplier of legal services. To operate our business, we need to collect some information about the people we deal with. Collecting personal information is also necessary in some circumstances to meet our legal obligations.

Who does Aston Reid Lawyers collect personal information about?

Aston Reid Lawyers collects and holds personal information about:

- our employees;
- contractors who provide services to us;
- · our clients;
- · our suppliers; and
- job applicants.

We do offer links to third party websites on our websites. Before disclosing your personal information on any other website, we advise you to examine the terms and conditions of using that website and its privacy statement.

What kind of personal information does Aston Reid Lawyers collect and how does Aston Reid Lawyers collect it?

The type of information we collect varies, depending on the purpose, and may include (but is not limited to) name, address, contact details, employment information and marketing information.

This information may be obtained through the submission of completed forms, provided in person or by telephone by the individuals themselves, or information obtained from a third party.

Where reasonable and practicable, we collect information directly from the individual. Aston Reid Lawyers may also collect information from other sources including publicly available information.

How do we treat sensitive information?

The Privacy Act defines 'sensitive information' as (among other things) information about a person's racial or ethnic origin, religion, membership of political bodies, trade union or other professional or trade association, sexual preferences or practices, criminal record or health. Sometimes it may be necessary for Aston Reid Lawyers to collect sensitive information.

If you provide Aston Reid Lawyers with sensitive information, it is our policy that this information will be used and disclosed only for the purpose for which it was provided or another directly related purpose, unless you agree otherwise, or unless use or disclosure of this information is allowed by law.

How do we store personal information?

Aston Reid Lawyers is required by the APPs and Part IIIA of the Privacy Act to safeguard the security and privacy of your information, whether you interact with us personally, by telephone, mail, over the internet or other electronic medium. Aston Reid Lawyers stores personal information at its own premises with the assistance of its service providers. Aston Reid Lawyers maintains strict procedures and standards and takes a range of steps to prevent unauthorised access to or, disclosure of, personal information and protect an individuals information from misuse or loss. Once an individual's information is no longer needed by Aston Reid Lawyers reasonable steps are taken to destroy or de-identify it.

How do we keep personal information accurate and up-to-date?

Aston Reid Lawyers seeks to ensure that the personal information it holds is accurate, complete and up-to-date. We realise that this information changes frequently with changes of address and other personal circumstances.
